## INTRODUCTION

This circular serves as an invitation of nominees from Departments, Public Entities and Municipalities, to attend training on the Revised National Industrial Participation Policy (NIPP).

## BACKGROUND

Cabinet adopted the Competitive Supplier Development Programme (CSDP) in 2007, which applies to procurement programmes and it is designed to increase the competitiveness, capacity and capabilities of the local supplier base, furthermore. The cabinet has approved amendments to the Preferential Procurement Policy Framework Act (PPPFA) Regulations in 2011 to empower the Minister of the Department of Trade and Industry (DTI) to designate industries, sectors and subsectors for local procurement by the state entities at a specified level of local content, and to enable organs of state through Clause 9.3 of the amended Regulations to design and adjudicate tenders in favour of localisation.

## PURPOSE

The objective of the training is to promote the NIP programme in Provinces in the light of Practice Note No. 9 of 2007/08 issued by National Treasury and a revised Standard Bidding Document 5 form, to all organs of the state in February 2008, to ensure that government buying entities procurement rules are in line with the NIPP Policy.

The NIPP policy came into effect in 1996, in terms of Cabinet Memorandum 10/1996. In terms of this Cabinet Memorandum, any state purchase from companies selling foreign products to Government in excess of USD10 million is required to acquire NIPP obligation that is calculated at 30% of the imported content of the purchase contract. The established amount, to be settled within fixed timescales, is invested into the South African economy. The NIPP Secretariat has been established to monitor and enforce this process.
