This circular serves to notify, inform and request support and cooperation from all Accounting Officers on the implementation of the Integrated Financial Management System (IFMS).


National Treasury has commissioned the State Information Technology Agency (SITA) to execute the introduction and implementation of the Integrated Financial Management System (IFMS) over a 5-year period with the objective of enhancing efficiencies in human resources, business intelligence, financial and supply chain management. The integration of all these business processes will result in the following;

1. Streamline or eliminates inefficient manual processes,
2. Eliminate disparate stand-alone systems,
3. Provides integrated, enterprise-wide common tools, processes and systems,
4. Integrates and increases control of budgeting, planning and financial management processes,
5. Provides enterprise-wide reporting and decision making support,
6. Presents opportunity for re-engineering with industry best practices and templates,
7. Incorporates new functionality and technology and possible platform for e-Business.

In order for the IFMS implementation to be successful and concluded within target time frames it is essential and imperative that all Accounting Officers fully support the initiative in their respective Departments. In this regard amongst others officials from Treasury and SITA will from time to time interact with the Departments to perform various functions including pre-assessments.
