SUBJECT: CENTRALISATION OF BANK STATEMENTS AND CHEQUE COLLECTIONS.

1. PURPOSE

The purpose of this circular is to explain the new process of collecting bank statements and cheques which is necessitated by the introduction of Safety web.

2. BACKGROUND

Departments are currently collecting bank statements and cheques directly from Standard Bank.

3. DISCUSSION

Safety web requires that all Cheques issued by Departments must be scanned by Mpumalanga Provincial Treasury (MPT) on the cheques scanner which is centralised at MPT for verification purposes. Due to the risk of cheques being lost before they are scanned by MPT it is therefore necessary for MPT to collect all the cheques for scanning before the cheques are handed back to Departments.

With effect from 10 December 2014 Mpumalanga Provincial Departments will collect their Cheques and Bank Statements from MPT at Interlinked Financial Systems Directorate and not from the bank as was the norm before.

4. RECOMMENDATION

It is recommended that Departments take note of the above mentioned Bank Statements and Cheques collections procedure.
