## PREPARATION AND SUBMISSION OF INTERIM FINANCIAL STATEMENTS (IFS)

The Mpumalanga Provincial Treasury is requesting all Departments to prepare Interim Financial Statements for the period ending 30 June 2018, 30 September 2018 and 31 December 2018. An accurate and complete IFS template must be submitted to the Provincial Treasury within 30 days after the end of the period.

In terms of Instruction Note 1 of 2013/14, Interim Financial Statements (IFS) must be prepared and submitted on a quarterly basis.

Provincial Departments are required to comply with the IFS instruction Schedule for the 2018/19 financial year. IFS should be submitted on the dates indicated below:-

Period	Submission date
1 April to 30 June 2018	31 July 2018
1 July to 30 September 2018	31 October 2018
1 October to 31 December 2018	31 January 2019

The IFS should be submitted to the internal auditors for review and the review report must be attached to the submissions to the Accounting Officer and Provincial Treasury.

The purpose of Interim Financial Statements is to detect and address issues that are posing a challenge to Departments with regard to Annual Financial Statements before year-end.

The following should be adhered to by Departments for the process to be effective:

- a) Proper closure of the books to be done
- b) All suspense accounts should be cleared to zero to enable Departments to provide complete financial information on expenditure and revenue.
- c) Stock counts and reconciliation of assets between BAS and LOGIS systems must be performed
- d) Reconciliation of assets, creditors, debtors and bank accounts must be performed.
- e) The expenditure management report should be scrutinized to ensure that all expenditure is correctly allocated to the budget appropriated.


