INVITATION TO CENTRAL SUPPLIER DATABASE WORKSHOP ON NEW DEVELOPMENTS

1. PURPOSE

This Circular serves as an invitation to the Supply Chain Management Practitioners / officials, Expenditure officials and other relevant officials in the Supply Chain Management units to attend the Central Supplier Database Workshop.

2. BACKGROUND

In terms of Section 38(1)(a)(iii) of the Public Finance Management Act, No. 1 of 1999 (PFMA), the accounting officer of a department and accounting authority of a public entity listed in Schedule 3C to the PFMA must ensure that their respective institutions have and maintain an appropriate procurement and provisioning system which is fair, equitable, transparent, competitive and cost effective.

It is also a requirement that all goods and services procured through quotations should be sourced from suppliers listed in the institution's prospective supplier database. To this end, the National Treasury has established a Central Supplier Database, which serves as a single source of information for all suppliers, as well as facilitating the verification of supplier information on behalf of all organs of states.

3. PROVINCIAL TREASURY'S DIRECTIVE TO DEPARTMENTS AND PUBLIC ENTITIES

As part of the Provincial Treasury's mandate to provide support and guidance on the implementation of Supply Chain Management in Departments and Public Entities, Supply Chain Management Practitioners / officials, Expenditure officials and other relevant officials in the Supply Chain Management units of departments and public entities are invited to the Central Supplier Database (CSD) workshop to discuss the recent enhancements introduced to the system.
